

ORDER ADVERTISING FOR BIDS FOR DRUG TESTING SYSTEM

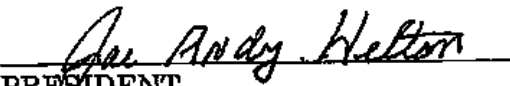
